Course Summary

The MSc Community Nursing [with Research Methods] [progression route] course is a progression route for students who have successfully completed a relevant PGDip in community nursing (that did not incorporate a Research Methods module) and wish to continue their academic study. It provides an opportunity to contribute to their own professional field of knowledge. Critical evaluation of either published primary research papers or data generated from a small scale study aims to facilitate development of the students' knowledge and understanding in relation to both the research process and the evidence base underpinning their own professional practice.

 To enable students to meet the challenges of undertaking research at master's level within their field of practice

On successful completion of the course, students will be awarded an MSc Community Nursing.

Course Delivery

The course is delivered at the Ipswich Campus. Students studying full-time on MSc Community Nursing [with Research Methods] [progression route] are required to complete the Research Methods module prior to undertaking the dissertation. Students are expected to undertake a total of 200 hours study for the Research Methods module, of which 36 will be contact hours, and 400 study hours for the Dissertation element, of which 20 will be individual supervision hours.

Course Assessment

The assessment methods used will be appropriate to assess each module/s intended learning outcomes. Assessment on the course will be in the form of a research proposal and dissertation coursework.

Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners.
