Course Summary

This programme of study has been designed to facilitate students in the development and evidencing of the knowledge, skills and competencies required to work at an advanced level within their own professional setting and role.

Students will be supported to develop a critical awareness of current problems and new insights at the forefront of their professional practice. Students will examine care development and delivery from their own professional standpoint and also take account of how other disciplines challenge and contribute to the quality of care delivery.

This course provides the opportunity for students to engage in a critical exploration of the Advanced Practice agenda in healthcare practice. The student will complete the dissertation module and Advanced Clinical Practice Portfolio which are mandatory for those wishing to complete studies towards the MSc Advanced Clinical Practice.

Course Aims

1. To enable students to engage in critical debate of issues pertinent to the roles and responsibilities within advanced professional practice and respond to them appropriately
2. To develop practitioners who are able to work in a professionally autonomous way demonstrating leadership within their area of practice and who are accountable for their own professional and clinical decisions
3. To enable students to critically evaluate personal and professional development needs in relation to advanced professional practice and implement appropriate responses
4. To enable students to meet the challenges of undertaking research at master's level within their field of practice
5. To develop an individual who is able to act as a role model and an educator to initiate change and management development opportunities within the clinical setting

Course Learning Outcomes

The following statements define what students graduating from the MSc Advanced Clinical Practice course will have been judged to have demonstrated in order to achieve the award. These statements, known as learning outcomes, have been formally approved as aligned with the generic qualification descriptor for level 7 awards as set out by the UK Quality Assurance Agency (QAA)⁶.

Awards

On successful completion of the course, students will be awarded a MSc Advanced Clinical Practice. If students pass the Dissertation but do not pass the Advanced Clinical Practice Portfolio, students may be eligible to receive the exit award of MSc Advancing Practice.

Course Delivery

The course is delivered at Ipswich. Students will be invited to attend two study days throughout the module. Day one will provide an overview of the module and support initial stages of project development. The dissertation is an independent piece of work with students taking responsibility for development, process and completion of their own project. Students will be allocated a supervisor to support them in the process and are allocated 30 hours of supervisory time.

Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course will be in the form of an oral presentation, portfolio submission and dissertation proposal and coursework.
