Course Summary

This course enables students to explore the theories and concepts that underpin and challenge practice and service provision locally, nationally and internationally. The programme has been developed to allow those in the care, education or community support

sector to further develop existing skills, and develop a broad range of practice skills, knowledge and understanding within key subject areas and to acquire and enhance their professional values. The 'applied' nature of the course is also vital, in that the learning outcomes and aims of the modules require contextualisation through the application of theory to practice in the relevant pathways. The content is current and delivered by experienced, subject specific lecturers.

Course Aims

1. To develop critical reflection, evaluation and argument in support of the capacity to evaluate practice evidence;
2. To evaluate and critically analyse political and economic context of evidence-based practice within an inter-professional arena and to isolate origins and key components of evidenced based needs;
3. To critically evaluate professional contribution to the support of children, young people or adults through transitions, in order to maintain/regain their individual emotional, social and developmental potential;
4. To develop and enhance the specific and generic/transferable skills required for employment at a supervisory or managerial level;
5. To develop critical awareness of both the local and national issues which impact upon the delivery of effective practice in an inter-professional environment;
6. To enhance and develop advanced scholarship within the specialist sector through critical evaluation and analysis of methodologies within current and previous research through academic investigation.

Course Learning Outcomes

The following statements define what students graduating from the BA (Hons) Applied Care Practice course will have been judged to have demonstrated in order to achieve the award. These statements, known as learning outcomes, have been formally approved as aligned with the generic qualification descriptor for level 6 awards as set out by the UK Quality Assurance Agency (QAA)⁶.

3. Critically evaluate the principles informing accountability for their scope of professional practice.
4. Provide a critical understanding of needs and priorities of service users and/or the community.
5. Provide a critical analysis of current local and national-level problems, policy and practice within their professional practice.
6. Critically analyse and evaluate practice and theoretical evidence which contributes to an understanding of practice and service delivery.
7. Apply professional curiosity to make links between research, theory and practice.
8. Critically reflect on own practice, self-development and give and receive constructive feedback.
9. To show self-direction and confidence in their individualised use of original approaches to problem solving.
10. Recognise their own responsibilities and wider accountability structure in relation to self and practice.
11. Develop focused interventions to meet service users' needs in relation to practice setting.
12. Critically evaluate the impact of professional and service interventions on service users.

On successful completion of the course, students will be awarded a BA (Hons) Applied Care Practice [progression route]

Course Delivery

The course is delivered at East Coast College Great Yarmouth Campus. Students studying full-time on BA (Hons) Applied Care Practice are likely to have approximately 260 contact hours for level 6. The contact hours will be a mix of lecture, seminar, presentations, tutorials, workshops and tutor directed online learning. Students will also be required to participate in approximately 10 hours of paid or voluntary work per week, usually in their own place of work. Students will be expected to find their own placement if additional work experience is required. Students will normally be expected to undertake 930 of independent study in the year but should be prepared for this to vary based on assignment deadlines and class exercises.

Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be 100% coursework (including essays, reports, presentations, group work, reflective learning journals and research projects).

Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute.
