Course Summary

Criminology and Sociology have distinct histories, philosophies, priorities and rationales in the social sciences, but with important similarities in terms of theoretical models used and approaches to research.

Criminology and Sociology at University of Suffolk is a 'rendezvous' programme that incorporates insights, methods and priorities from not only Criminology and Sociology but also Psychology, Law, Social Policy and Philosophy. This interdisciplinary focus exposes you to a range of contemporary theoretical and empirical debates concerning crime, responses to criminal behaviour and pressing developments in domestic and global society. As a Criminology and Sociology student, you will be encouraged to develop good analytical and reasoning skills across the programme, engaging with diverse academic literature and evaluating a rich body of research and evidence that can shed light on the key challenges facing society, and how to overcome them.

As a Criminology and Sociology student, you will be encouraged to critically engage with national and international dimensions of crime, justice and fairness. Strong emphasis is placed on challenging "common-sense" notions of crime, harm and injustice by critically examining research and making informed decisions based on available evidence. You will be introduced to varying research methods and ethical considerations, so you can challenge and understand the limits and ambiguities of research whilst assessing its value. This will provide an excellent theoretical and practical platform for completion of a third-year independent project in an area of personal or career interest.

Criminology and Sociology at the University of Suffolk also places emphasis on the real world, seeking to develop the skills needed for careers across the private and public sectors. By examining such complex and challenging topics as inequality, violence, social change, globalisation, migration, and gender, you will become sensitive to the wider context of our lived experience and learn to look beyond a narrow focus on the individual in any situation. This attention to interdisciplinary context will allow you to make more informed and evidence-based decisions. Studying Criminology and Sociology will equip you with analytical, decision making and research skills necessary for many vocations. This course will empower you to be innovative, ask awkward questions, and develop good teamwork skills. It is this combination that makes Criminology and Sociology graduates employable.

Course Aims

1. Provide you with a critical and interdisciplinary understanding of the key concepts, theories, and debates in Sociology and Criminology, enabling them to explore the complex relationships between individuals, social structures, crime, and justice.
2. Develop your ability to apply a range of research methods and analytical techniques to investigate social and criminological issues, fostering intellectual curiosity, methodological competence, and ethical awareness.
3. Cultivate your capacity for critical thinking, independent judgement, and evidence-based reasoning, enabling them to engage with contemporary social challenges and contribute to informed debate and policy development.
4. Enhance your communication, digital, and professional skills, including the ethical use of AI and data, preparing them to effectively convey complex ideas to diverse audiences and operate in a variety of professional contexts.
5. Support your personal and professional development, encouraging reflective practice, self-directed learning, and the acquisition of transferable skills necessary for graduate employment, further study, and active citizenship.

Course Learning Outcomes

2. Critically analyse and evaluate social diversity, inequalities, and major social problems at local, national, and global levels, using interdisciplinary perspectives and ethical frameworks.
3. Apply appropriate methods of sociological and criminological enquiry, including qualitative, quantitative, comparative, and mixed methods, to design, conduct, and report research using primary and secondary sources.
4. Use scholarly research and credible data to develop compelling, evidence-based arguments, solve problems, and evaluate competing perspectives in both sociological and criminological contexts.
5. Critically assess and apply relevant analytical techniques and theoretical frameworks to initiate and conduct independent projects, demonstrating intellectual flexibility and methodological rigour.
6. Formulate and investigate sociologically and criminologically informed questions, making judgements based on critical evaluation of arguments, assumptions, and evidence.
7. Communicate information, ideas, and solutions effectively and professionally to both specialist and non-specialist audiences, using appropriate academic conventions and digital tools, including ethical use of AI.
8. Demonstrate self-awareness and employability skills, including independent learning, decision-making, ethical practice, and the ability to reflect on personal and professional development in preparation for graduate employment or further study.

Course Structure

The BSc (Hons) Criminology and Sociology comprises modules at levels 4, 5 and 6. Module Specifications for each of these modules is included within the course handbook, available to students on-line at the beginning of each academic year.

When selecting modules, students must ensure that their choices provide equal coverage of both subjects. Across Levels 5 and 6, students are required to complete 120 credits in each subject, with a minimum of 30 credits in each subject at each level.

Some optional modules may not run in every year of study, and the availability of optional modules depends on the level of student demand, the availability of specialist staff and timetabling constraints. In addition, we regularly review our curriculum to ensure it is up-to-date, relevant, draws on the latest research and addresses contemporary issues. As a result, the modules we offer may change over the course of your degree.

Optional recovery modules are only available in the exceptional circumstances where a student must retrieve credits to ensure progression or where a standard optional module cannot be delivered.

Awards

On successful completion of the course, students will be awarded either a BSc (Hons) Criminology and Sociology (with Professional Placement), BSc (Hons) Criminology and Sociology (with Professional Placement and Study Abroad), or BSc (Hons) Criminology and Sociology (with Study Abroad) depending on the sandwich route taken. Students who leave the course early may be eligible for a BSc Criminology and Sociology on successful completion of 300 credits (including at least 180 credits at Level 5 or above and at least 60 credits at Level 6); a DipHE Criminology and Sociology on successful completion of 240 credits including all mandatory modules at levels 4 and 5; a CertHE Criminology and Sociology on successful completion of 120 credits including all mandatory modules at level 4.

Course Delivery

The course is delivered at Ipswich. Students studying full-time on BSc (Hons) Criminology and Sociology are likely to have approximately 12 contact hours for level 4, 9 contact hours for level 5 and 9 contact hours for level 6. The contact hours will be a mix of lectures, seminars, practical activities, tutorials, workshops and guided learning activities through the online learning environment. Students will normally be expected to undertake 28 hours of independent study in an average week but should be prepared for this to vary based on assignment deadlines and class exercises.

Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes.

Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute.

Course Costs

Students undertaking BSc (Hons) Criminology and Sociology will be charged tuition fees as detailed below.
