### Course Summary

The BA (Hons) in Early Years & Primary Practice with Early Childhood Graduate Practitioner is an intensive one year full-time / two-year part-time work-based higher education qualification for experienced Early Years Practitioners employed in the Early Years sector who have successfully completed a Foundation Degree in Early Years & Primary Practice, or a similar undergraduate course.

The programme focuses on developing student's knowledge and understanding of the principles and values that underpin the learning and development of young children primarily from 0-12 years, and to critically apply these values and principles in order to develop their professional practice. To gain entry to the programme, students are required to have previously completed a (HE) level 5 undergraduate programme which includes work-based learning in a relevant setting and are able to continue working in relevant employment whilst studying. Students will require the support of their employer and a mentor to successfully complete the course of study.

### Course Aims

- Develop knowledge and a critical understanding of values and practices that underpin education and children's learning in the early and primary years.
- Develop key transferable skills of value in employment, further study, and continuing professional development.
- Develop the capacity to evaluate evidence drawn from practice and to develop critical skills of evaluation and argument to support the practice of practitioners working with children in the early years and primary sector.
- Develop the ability to critically reflect on own professional practice, develop and make informed recommendations to improve practice.
- Develop a critical understanding of appropriate research methods and apply these to research studies related to children and or, the early years and primary sectors.

### Course Learning Outcomes

The following statements define what students graduating from the BA (Hons) in Early Years & Primary Practice with Early Childhood Graduate Practitioner course will have been judged to have demonstrated in order to achieve the award. These statements, known as learning

outcomes, have been formally approved as aligned with the generic qualification descriptor for level 6 awards as set out by the UK Quality Assurance Agency (QAA)<sup>6</sup>.

By the end of the BA (Hons) in Early Years & Primary Practice with Early Childhood Graduate Practitioner students will be able to demonstrate:

1. Detailed knowledge and critical understanding of the values and practice that underpin children's learning and development including a critical understanding of how policy initiatives can impact young children and families.
2. Well-developed conceptual understanding that enables the student to critically engage with a range of key transferable skills.
3. Well-developed ability to critically evaluate arguments, assumptions, abstract concepts, and data (that may be incomplete), to make judgements, and to frame appropriate questions to achieve a solution - or identify a range of solutions - to a problem and apply these to the role and practice of working with children.
4. An ability to critically reflect on own professional practice and to apply the methods and techniques that they have learned to review, consolidate, extend, and apply their knowledge and understanding, and to initiate and carry out research/project/s to improve practice.
5. Well-developed qualities and transferable skills necessary for employment requiring, a) the exercise of initiative and personal responsibility, b) decision-making in complex and unpredictable contexts, c) the learning ability needed to undertake appropriate further continued professional development.

### Awards

On successful completion of the course, students will be awarded a BA (Hons) in Early Years & Primary Practice with Early Childhood Graduate Practitioner.

### Course Delivery

The course is delivered at Ipswich campus and online. Students studying full-time on the BA (Hons) in Early Years & Primary Practice with Early Childhood Graduate Practitioner are likely to have approximately 210 hours of tutor structured and on-line learning. Tutor structured learning will be a mix of lectures, workshops, seminars, and guided learning activities through our online learning environment. Students will be provided with tutorial support throughout the course and be expected to engage with around 15 hours of independent study per week but should be prepared for weekly workload to vary based on assignment deadlines and class exercises. Students will also be required to participate in 12 hours of work placement per week full-time and 6 hours per week part-time. Students will be expected to find their own placement.

### Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be 100% coursework, assessments will be varied and include portfolios related to practice, essays, reports, and presentations.

### Special Features

The course embeds the Early Childhood Graduate Competencies, developed by the Early Childhood Degree Network (ECSDN) [ECSDN Graduate Practitioner Competencies](#) and supported by the Department for Education (DfE). These competencies are ingrained within both the FdA/BA (Hons) EYPP courses and builds on our already well-established early years curriculum by further promoting the understanding, knowledge and skills required for work in the contemporary early years and primary sectors. Students have the opportunity to complete

and have these competencies assessed as part of their level 6 studies. Students who successfully complete the competencies will then be able to claim Graduate Practitioner Status (GPS).

### Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute.

### Course Costs

Students undertaking BA (Hons) in Early Years & Primary Practice with Early Childhood Graduate Practitioner [progression route] will be charged tuition fees as detailed below.
