Course Summary

The MA International Relations aims to provide you with the knowledge and skills needed in the field of international relations, in a range of employment settings. It explores the theories, practices and priorities of greatest relevance to the profession of international relations today. It addresses not only the most pressing issues, but those on the cutting edge of contemporary agendas: environment, health, populism and ideology, race and international security.

Your career development drives our programme. The MA aims to develop the skills needed by successful international relations professionals. You will learn how to use the intelligence cycle, how to analyse and disseminate research products, and how to develop and pursue a research agenda that generates subject matter expertise. You will have the opportunity to conduct an independent project marking the culmination of your studies and making a substantial, unique contribution to knowledge.

Moreover, a work placement module will offer a unique opportunity to apply your learning, and reflect on your career development, in the practitioner environment.

The combination of applied theory and contemporary policy casework, strengthened by a focus on skills growth, will help you grow as a postgraduate student and as a professional in this diverse and dynamic field of work.

Course Aims

- Enhance your knowledge, skills, and career progression in the broad field of international relations
- Promote and develop robust advanced professional analysis with a normative and ethical awareness
- Develop practical skills such as identifying courses of action to add value to decision making in public and private contexts alongside intelligence and data analysis

Course Learning Outcomes

The following statements define what students graduating from the MA International Relations course will have been judged to have demonstrated in order to achieve the award. These statements, known as learning outcomes, have been formally approved as aligned with the generic qualification descriptor for level 7 awards as set out by the UK Quality Assurance Agency (QAA)⁶.

1. Show a deep and systematic knowledge of key contemporary aspects of international relations such as security, diplomacy and international law
2. Apply advanced knowledge based on critical awareness of contemporary issues in international relations to decision making contexts for state and non-state actors
3. Systematically analyse and evaluate evidence using the conceptual frameworks and theoretical approaches of international relations
4. Demonstrate self-direction and initiative in the critical engagement with relevant international issues using advanced methods of research and analysis.
5. Demonstrate self-direction and initiative in tackling and solving problems through the independent design, production and communication of a research project that shows advanced use of appropriate research methods for a range of international relations issues
6. Research and present complex arguments orally and in writing on issues showing sound reasoning where there is ambiguity.

Optional modules available in any year will be communicated to you prior to your enrolment to facilitate module choice. Some optional modules may not run in every year of study, and the availability of optional modules depends both on student demand and the availability of specialist staff.

Awards

On successful completion of the course, students will be awarded an MA International Relations. Students who leave the course early may be eligible for a PgD International Relations on successful completion of 120 credits including Applied International Relations Theory and Intelligence and International Security, or a PgC International Relations on successful completion of 60 credits including Applied International Relations Theory and Intelligence and International Security.

Course Delivery

The course is delivered at the University of Suffolk. Students studying full-time on MA International Relations are likely to have approximately 6 contact hours across one to two days per week. The contact hours will be a mix of lectures and seminars, and students will have the opportunity to take a work placement module towards the end of the academic year. Students will be expected to find their own placement and undertake approximately 140 placement hours. Students will normally be expected to undertake 37 hours of independent study in an average week, but should be prepared for this to vary based on assignment deadlines and class exercises.

Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be majority coursework (including case studies, policy briefs, presentations, podcast, reports, group work, portfolio, and research project), and some practical assessments.
