Course Summary

Law is taught from a range of perspectives, based on the finest traditions of legal education and recent innovations for the 21st century. Our approach is to examine law well beyond basic legal rules and legal institutions, taking account of wider contexts and discourses that allow deeper understanding of law in society. With this approach, the University of Suffolk provides students with firm grounding in the subject of law and the contexts in which law functions. Equally important is the breadth and depth of education that this subject facilitates. Students will be equipped to take on challenging questions about law and related issues, and to apply their knowledge and skills in a variety of contexts. This ethos runs right through all subjects in the law curriculum and enhanced even more with combinations in other social sciences.

This course places emphasis on the use of law to solve problems. With this in mind, teaching and learning on this course is designed to encourage the development of strong legal and problem-solving skills. In addition to engaging in legal reasoning, students also learn how to analyse the impact of law in society. Though law is often studied as a distinct subject, its methods and analytical approaches draw on fields within the humanities and the social sciences. Students will have the opportunity to develop skills in the use of a wide range of legal research methods and approaches, with increasing emphasis on independent work as you progress through your course. The course also emphasises the importance of developing a range of legal and academic skills to enable students to learn, research and analyse the law as independent learners to prepare them for further study or a variety of legal careers. This course also recognises the importance of practical legal skills for employability, and endeavours to infuse skills-based learning on all modules.

As a criminology student at University of Suffolk, you will be able to critically engage with national and international dimensions of crime and criminal justice policy, and develop well-informed views on contested public issues. There is a strong emphasis on challenging “common-sense” notions of criminal and deviant behaviours by critically examining academic research and making informed decisions based on available evidence. To this end, you will be introduced to a variety of research methods and ethical considerations, so that you can challenge and understand the limitations and ambiguities of empirical research, whilst assessing its value. This will provide an excellent theoretical and practical platform for the completion of a third-year independent project in an area of personal or career interest.

Students who opt for the one-year placement route will benefit from a valuable opportunity to put their legal knowledge and skills into practice within a real-world environment — with the

exciting option to complete their placement abroad. A placement year abroad offers not only practical legal experience but also the chance to immerse oneself in a new legal culture, gain international perspectives on legal systems, and develop cross-cultural communication skills that are increasingly valued in the global legal marketplace. The placement year serves as a bridge between academic study and professional life, offering insights into the inner workings of legal institutions, firms, or policy settings.

By working within an international context, students broaden their legal outlook, adapt to different professional practices, and gain first-hand exposure to comparative legal frameworks. This global experience deepens their understanding of law in a truly international sense, and fosters adaptability, confidence, and intercultural awareness. Whether engaging with live legal issues, client work, or policy development, students return from their placement better equipped for the challenges of both domestic and international legal careers. The immersive nature of the year — especially when undertaken abroad — enhances employability, strengthens problem-solving and analytical skills, and provides students with a standout experience that sets them apart in a competitive legal job market or in further postgraduate study.

Course Aims

1. To provide students with a strong understanding of core and specialist areas of law, building knowledge that reflects both the foundations of the legal system and its development in response to modern challenges.
2. To cultivate a questioning and critical approach to the understanding of human behaviour and society.
3. To equip students with the skills to research law effectively, using a wide range of legal materials—such as cases, legislation, and academic sources—to support careful analysis and argument.
4. To encourage students to consider law in its wider context, reflecting on ethical issues, questions of justice and fairness, and the role law plays in shaping public life.
5. To build confidence in legal communication, helping students express complex legal ideas clearly and persuasively, both in writing and when speaking, using appropriate language and evidence.
6. To prepare students for future careers, by developing practical legal skills, engaging with legal technologies, and understanding how law is practised in real-world professional settings.
7. To foster independence and self-direction, particularly through opportunities for students to design and complete a substantial legal research project in an area of personal or professional interest.
8. To provide students with the opportunity to apply their legal knowledge and skills in a professional setting, including the option to undertake a placement abroad, enabling them to gain practical experience, global perspectives, and intercultural competence to enhance their personal and professional development in a diverse legal landscape.

6. Articulate complex legal points and arguments based on credible evidence, using appropriate language
7. Demonstrate relevant professional legal skills and engagement with relevant technology
8. Demonstrate intellectual independence through the design, development, and completion of an independent project.

Optional modules available in any year will be communicated to you prior to your enrolment to facilitate module choice. Some optional modules may not run in every year of study, and the availability of optional modules depends on the level of student demand, the availability of specialist staff and timetabling constraints. In addition, we regularly review our curriculum to ensure it is up-to-date, relevant, draws on the latest research and addresses contemporary issues. As a result, the modules we offer may change over the course of your degree.

Awards

On successful completion of the course, students will be awarded a LLB (Hons) Law with Criminology (with Professional Placement and Study Abroad).

Students who leave the course early may be eligible for a LLB Law with Criminology (with Professional Placement and Study Abroad) on successful completion of 300 credits including all mandatory modules at levels 4, 5, the placement and study abroad year, and at least 60 credits at level 6, to include Public Law in Context and Advanced Law in Practice, a DipHE Law with Criminology (with Professional Placement and Study Abroad) on successful completion of 240 credits including all mandatory modules at levels 4 and 5 and the sandwich year, a DipHE Law with Criminology on successful completion of 240 credits including all mandatory modules at levels 4 and 5, or a CertHE Law with Criminology on successful completion of 120 credits including all mandatory modules at level 4.

Course Delivery

The course is delivered at Ipswich main campus. Students studying full-time on LLB (Hons) Law with Criminology (with Professional Placement and Study Abroad) are likely to have approximately 12 tutor led structured learning hours per week for level 4, 8 tutor led structured learning hours per week for level 5 and 8 tutor-led structured learning hours per week for level 6. The tutor led structured learning hours will be a mix of online activities, and face-to-face learning sessions. Students will normally be expected to undertake 32 hours of independent study in an average week but should be prepared for this to vary based on assignment deadlines and class exercises. Where feasible and appropriate, learning sessions will be recorded and made available through the virtual learning environment.

Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes.

Special Features

The LLB (Hons) Law with Criminology (with Professional Placement and Study Abroad) incorporates the seven core subjects as required by the Bar Qualification Manual and is mapped against the areas of law and skills tested in the Solicitor's Qualifying Exams. The course also aligns with the QAA Subject Benchmark Statement for Law (March 2023) and the Subject Benchmark Statement for Criminology (2022) and incorporates all of the foundations of legal knowledge subjects as required by the Bar Qualification Manual.

The course has also been digitally enhanced to ensure students have the skills needed to operate in an increasingly technologically driven workplace. Students learn how to use AI ethically and professionally in the field of law (including AI-based assessments), how to engage with legal repositories such as Lexis and Westlaw, how to use advanced research software such as SPSS and Atlas.ti, how to fully engage in virtual environments, have the opportunity to use VR headsets for legal simulations (where available), and advanced skills in standard operating packages such as Microsoft365.

Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute to the course.

Course Costs

Students undertaking LLB (Hons) Law with Criminology (with Professional Placement and Study Abroad) will be charged tuition fees as detailed below.
