This definitive record sets out the essential features and characteristics of the LLB (Hons) Law with Criminology course. The information provided is accurate for students entering level 4 in the 2026-27 academic year<sup>5</sup>.

### Course Summary

The LLB (Hons) Law with Criminology students acquire knowledge of foundational and specialist areas of law, whilst developing practical and professional legal skills in partnership with the local legal community, preparing students for their future careers, moving from guided learning to intellectual independence and academic confidence.

Law is taught from a range of perspectives, based on the finest traditions of legal education and recent innovations for the 21st century. Our approach is to examine law well beyond basic legal rules and legal institutions, taking account of wider contexts and discourses that allow deeper understanding of law in society. With this approach, the University of Suffolk provides students with firm grounding in the subject of law and the contexts in which law functions. Equally important is the breadth and depth of education that this subject facilitates. Students will be equipped to take on challenging questions about law and related issues, and to apply their knowledge and skills in a variety of contexts. This ethos runs right through all subjects in the law curriculum which includes a number of modules specifically designed to provide opportunities to apply your knowledge and skills in different contexts.

This course places emphasis on the use of law to solve problems. With this in mind, teaching and learning on this course is designed to encourage the development of strong legal and problem-solving skills. In addition to engaging in legal reasoning, students also learn how to analyse the impact of law in society. Though law is often studied as a distinct subject, its methods and analytical approaches draw on fields within the humanities and the social sciences. Students will have the opportunity to develop skills in the use of a wide range of legal research methods and approaches, with increasing emphasis on independent work as you progress through your course. The course also emphasises the importance of developing a range of legal and academic skills to enable students to learn, research and analyse the law as independent learners to prepare them for further study or a variety of legal careers. This course also recognises the importance of practical legal skills for employability, and endeavours to infuse skills-based learning on all modules.

As a criminology student at University of Suffolk, you will be able to critically engage with national and international dimensions of crime and criminal justice policy, and develop well-informed views on contested public issues. There is a strong emphasis on challenging “common-sense” notions of criminal and deviant behaviours by critically examining academic research and making informed decisions based on available evidence. To this end, you will be introduced to a variety of research methods and ethical considerations, so that you can challenge and understand the limitations and ambiguities of empirical research, whilst assessing its value. This will provide an excellent theoretical and practical platform for the completion of a third-year independent project in an area of personal or career interest.

### Course Aims

1. **To provide students with a strong understanding of core and specialist areas of law**, building knowledge that reflects both the foundations of the legal system and its development in response to modern challenges.

2. **To cultivate a questioning and critical approach** to the understanding of human behaviour and society.
3. **To equip students with the skills to research law effectively**, using a wide range of legal materials—such as cases, legislation, and academic sources—to support careful analysis and argument.
4. **To encourage students to consider law in its wider context**, reflecting on ethical issues, questions of justice and fairness, and the role law plays in shaping public life.
5. **To build confidence in legal communication**, helping students express complex legal ideas clearly and persuasively, both in writing and when speaking, using appropriate language and evidence.
6. **To prepare students for future careers**, by developing practical legal skills, engaging with legal technologies, and understanding how law is practised in real-world professional settings.
7. **To foster independence and self-direction**, particularly through opportunities for students to design and complete a substantial legal research project in an area of personal or professional interest.

## Course Learning Outcomes

The following statements define what students graduating from the LLB (Hons) Law course will have been judged to have demonstrated in order to achieve the award. These statements, known as learning outcomes, have been formally approved as aligned with the generic qualification descriptor for level 6 awards as set out by the UK Quality Assurance Agency (QAA)<sup>6</sup>.

1. Demonstrate extensive knowledge and understanding of foundational and specialist areas of law and effectively deploy coherent and detailed knowledge of key aspects of criminology, such as criminalisation, victimisation, and the social, legal and cultural meanings of crime.

3. Identify, analyse, and utilise a wide range of primary and secondary sources
4. Critically evaluate ambiguity, uncertainty, gaps, and growth points in the law, considering ethical principles, access to justice, and the wider societal context.

6. Articulate complex legal points and arguments based on credible evidence, using appropriate language
7. Demonstrate relevant professional legal skills and engagement with relevant technology
8. Demonstrate intellectual independence through the design, development, and completion of an independent project

Not all optional modules are not available every year and the choice available each year will be communicated to students before enrolment. The specific optional modules available each year will be based on staff expertise, student demand and operational requirements of the school.

**Awards**

On successful completion of the course, students will be awarded a LLB (Hons) Law with Criminology. If you leave the course early you may be eligible for an LLB Law with Criminology (awarded upon successful completion of 300 credits, including all mandatory modules at levels 4 and 5, and at least 60 credits at level 6 including Public Law in Context and Advanced Law in Practice modules), a Diploma of Higher Education in Law with Criminology on successful completion of 240 credits including all mandatory modules at levels 4 and 5, or a Certificate of

Higher Education in Law with Criminology on successful completion of 120 credits including all mandatory modules at level 4.

### **Course Delivery**

The course is delivered at Ipswich main campus. Students studying full-time on LLB (Hons) Law with Criminology are likely to have approximately 12 tutor led structured learning hours per week for level 4, 8 tutor led structured learning hours per week for level 5 and 8 tutor-led structured learning hours per week for level 6. The tutor led structured learning hours will be a mix of online activities, recorded and live online sessions and face-to-face learning sessions. Students will normally be expected to undertake 32 hours of independent study in an average week, but should be prepared for this to vary based on assignment deadlines and class exercises.

### **Course Assessment**

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes and will include essays, presentations, vivas, exams.

### **Special Features**

The LLB (Hons) Law with Criminology incorporates the seven core subjects as required by the Bar Qualification Manual and is mapped against the areas of law and skills tested in the Solicitor's Qualifying Exams. The course also with the QAA Subject Benchmark Statement for Law (March 2023) and the Subject Benchmark Statement for Criminology (2022) and incorporates all of the foundations of legal knowledge subjects as required by the Bar Qualification Manual.

### **Course Team**

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute to the course.

### **Course Costs**

Students undertaking LLB (Hons) Law with Criminology will be charged tuition fees as detailed below.
