The BA (Hons) Social Work Course is designed to prepare students for the constantly changing and challenging environment of social work and social care practice. Underpinned by a strong commitment to social justice, the programme combines a clear academic focus on the theoretical underpinnings of social work with careful attention to practice skills, knowledge, values and personal and professional development. Relevant knowledge and theory for practice includes psychological and sociological theories applied to a range of practice contexts, approaches to research and evidence informed practice, knowledge and understanding of law and policy. Employers in statutory and private, voluntary and independent sectors provide practice-learning opportunities for levels 5 and 6. In addition, skills development is supported through practice workshops with people with lived experience (service participants) and practitioners, focusing on, for example, communication, direct and specialist work, and inter-professional practice. Study time is built into the programme for students to pursue their own increasingly independent learning and in Level 6; students are expected to develop this to produce a dissertation with individual supervision.

### **Course Aims**

The aims of the BA (Honours) Social Work degree course are:

- At the point of completion of the course, produce social work graduates who meet all six SWE (2019) Professional Standards, nine domains of the Professional Capabilities Framework (BASW 2018) at qualifying level, and who are therefore eligible to apply for professional registration as social workers with SWE.
- To deliver a coherent curriculum that is relevant to contemporary social work practice, which is evidence-informed including by up-to-date research, theory, knowledge, social work values and practice developments.
- To utilise diverse teaching, learning and assessment methods which support the development of competent, thoughtful and reflective practitioners, committed to personal and professional development with a sound ethical base, in line with: the Subject Benchmark Statement for Social Work (QAA, 2019); the Professional Standards (SWE, 2019), the Professional Capabilities Framework (BASW, 2018), the curriculum guides (TCSW/Higher Education Academy, 2012), and the Education and Training Standards (SWE, 2021).
- To work closely with key partners (external examiners, employers, social work managers and practitioners, people who use social work services, students and other professionals) to ensure that the course is informed by their views and responsive to their knowledge and experiences in order to ensure the relevance of the course for contemporary social work practice and to promote graduates' employability.
- Deliver the prescribed curriculum for the degree based upon documentation provided by Social Work England and the Quality Assurance Agency's benchmark statement for social work (QAA, 2016), the Framework for Higher Education Qualifications in England, Wales and Northern Ireland (SHEQ), SWE Professional Standards (2019) and the Professional Capabilities Framework, managed by BASW (2018). Modules are also mapped against the Knowledge Skills Statements (KSS) for children and families and adults.

- Provide students with an opportunity to develop a broad range of practice skills, knowledge and understanding of key subject areas and acquire a clear sense of social work values.

### Course Learning Outcomes

The following statements define what students graduating from the BA (Hons) Social Work course will have been judged to have demonstrated in order to achieve the award. These statements, known as learning outcomes, have been formally approved as aligned with the generic qualification descriptor for level 6 awards as set out by the UK Quality Assurance Agency (QAA)<sup>6</sup> and are mapped against Social Work England Professional Standards and the Professional Capabilities Framework (BASW).

1. Understanding of what the regulatory body (SWE) requires of them as qualified social workers.
2. Professional capability and accountability in safely undertaking social work duties, tasks and responsibilities (PS 3 and 6)
3. Development in a range of cognitive, analytical, critical and reflective skills so that they can utilise assessment frameworks and undertake risk assessments, recognising and responding to abuse and neglect (PS 3).
4. Subject-specific knowledge and understanding to inform professional practice to include application of appropriate legal frameworks (PS 3 and 4).
5. Practice that is based on social work principles and values as embodied in BASW's (2018) Professional Capabilities Framework and the SWE's (2019) Professional Standards (PS 1, 5 and 6).
6. Development of appropriate boundaries, resilience and of strategies to manage challenges and change within the increasingly complex and demanding social care context to maintain fitness to practice (PS 4).
7. Development of a strong and positive approach to social work which emphasises the high standards and achievements that competent and capable social workers who are fit to practice can accomplish (PS 3).
8. Development as an effective and autonomous professional whose assessment and decision-making skills and recommendations reflect sound professional judgements within an uncertain and complex professional context (PS 2, 3, 4 and 5).
9. Demonstrate understanding of the impact of cultural factors, equality and diversity in practice contexts and be able to practice in an anti-discriminatory way, promoting social justice, equality and inclusion (PS 2, 3 and 6).
10. Have the knowledge and ability to share information within appropriate boundaries (PS 4 and 6)
11. Be able to effectively communicate in all areas of practice with people who use services, carers and other professionals both verbally and in written form (PS 2).

12. Ability to make and maintain appropriate professional relationships with others, networking and working in partnership with individuals and teams including a commitment to multi-disciplinary/inter-professional practice (PS 2).

We regularly review our curriculum to ensure it is up-to-date, relevant, draws on the latest research and addresses contemporary issues. As a result, the modules we offer may change over the course of your degree.

### Awards

On successful completion of the course, students will be awarded a BA (Hons) Social Work and be eligible to apply for registration with Social Work England. Students who leave the course early may be eligible for a Diploma of Higher Education Social Studies on successful completion of 240 credits including all mandatory modules at levels 4 and 5, or a Certificate of Higher Education on successful completion of 120 credits including all mandatory modules at levels 4.

### Course Delivery

The course is delivered at Ipswich. Students studying full-time on BA (Hons) Social Work are likely to have approximately 268 contact hours for level 4, 193 contact hours for level 5 and 90 contact hours for level 6. The contact hours will be a mix of lectures, skills workshops, tutor groups and personal academic coach sessions. In addition, students will undertake at least 170 days of learning in statutory, private, voluntary and /or independent sector settings. Placements will be arranged by the University in conjunction with Local Authority Teaching Partnership and other placement providers. Students will normally be expected to undertake between 5-12 hours of independent study in an average week, but should be prepared for this to vary based on number of days in placement, assignment deadlines and classroom based and on-line environment activities.

### Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be approximately 100% coursework (including blogs, essays, case studies, reports, presentations, group work, reflective learning accounts, research projects and portfolios).

### Special Features

The BA (Hons) Social Work course is approved by Social Work England. 'Social Worker' is a protected title, on completion of this course graduates are eligible to apply for registration with Social Work England.

### Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute and are registered as Social Workers with SWE.
