to the public health policy agenda. The course requires students to develop knowledge, understanding and skills of Specialist Community Public Health Nursing and contemporary public health approaches to practice in line with the Office for Health Improvement and Disparities. A requirement within this context of practice is for health care professionals to develop a comprehensive range of skills. These will enable them to develop and lead population and individual based public health services designed to tackle inequalities in health, prevent ill health and to work in partnership with individuals, families, workplaces and communities. This requires an understanding of the communities and environments where people live and work.

## **Course Aims**

In providing the Postgraduate Diploma the course team and University aim to enable you to:

- 1. Achieve recognition, proficiency and registration as a Specialist Community Public Health Nurse within an identified field of practice.
- 2. Explore and analyse a range of theoretical concepts, perspectives, policies and evidence related to public health and to consider their application to specialist community public health practice: health visiting, school nursing or occupational health nursing.
- 3. Engage in critical understanding and debate on the issues and factors associated with addressing inequalities in health and the associated concepts of social justice, equity, human rights, social inclusion, exclusion, vulnerability and resilience.
- 4. Critically appraise, analyse and apply relevant ethical, moral, and legal theories and reasoning within the provision and development of Specialist Community Public Health Nursing.
- 5. Develop knowledge and skills in influencing and leading service delivery, development and innovation; collaborating with others to improve and embed sustainable changes within public health nursing practice,
- 6. Deliver professional practice with empathy, compassion, cultural competence and resilience to improve people's health and wellbeing.
- 7. Critically analyse and explore the concepts of partnership and collaborative working in specialist community public health nursing to prevent ill health, protect health and promote wellbeing.
- 8. Critically analyse their own public health skills and personal development and develop reflective skills in practice whilst promoting a high level of autonomy and self-direction within a multidisciplinary and multiprofessional environment.
- 9. Consider and effectively manage the conflicting priorities, risks, diverse complexities, ambiguities and uncertainties in specialist community public health nursing
- 10. Critically analyse opinion, assumptions, concepts and data to determine health needs and become effective and creative problem solvers seeking to understand and address health inequalities.
- 11. Locate, critically appraise, use, generate and apply relevant research and data in public health with an emphasis on their practice/ professional context.

12. Develop a range of intellectual skills reflecting the rigour required at master's level which will enable the continuation of their personal and professional development beyond the framework of the course.

#### Awards

On successful completion of the course, students will be awarded a PgD Specialist Community Public Health Nursing (Occupational Health Nursing). Students who leave the course early may be eligible for a Postgraduate Certificate in Public Health Nursing Studies on successful completion of 60 credits excluding the practice requirements.

### **Course Delivery**

The course is delivered at Ipswich. Students studying full-time on PgD Specialist Community Public Health Nursing (Occupational Health Nursing) are likely to have approximately 305 contact hours. The contact hours will be a mix of lectures and seminars. Students will also be required to participate in 825 hours of work placements. Placements will be arranged by the University/Employer. Students will normally be expected to undertake 720 hours of independent study, which is inclusive of tutor set online learning, but should be prepared for this to vary based on assignment deadlines and class exercises.

### **Course Assessment**

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessments will mainly be coursework (including essays, reports, presentations, group work, reflective learning journals and research projects); but oral examinations and practical assessments are also included.

#### **Special Features**

On successful completion of the PgD Specialist Community Public Health Nursing Occupational Health Nursing students are eligible for registration with the Nursing Midwifery Council on part 3 of the register with the NMC.

#### **Course Team**

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute and are registered with the NMC.

#### **Course Costs**

Students undertaking the PgD Specialist Community Public Health Nursing-School Nursing have their course tuition fees paid for by NHSE.

Students are likely to incur other costs for travel to university and books, although the resources are also available via the library free of charge.

#### Course Costs for Self-funding/ non- NHS/ self- employed students

Postgraduate tuition fees will apply for self- funding/ non-NHS/ self-employed students. Please contact the University for further details

In addition, self-funding/ non-NHS/ self- employed students will be expected to fund DBS checks and any additional costs associated with placement (equipment, uniforms, travel etc) or the course such as books, although the resources are also available via the library free of charge.
