This definitive record sets out the essential features and characteristics of the BA (Hons) Art Practice course. The information provided is accurate for students entering level 4 in the 2019-20 academic year<sup>5</sup>.

**Course Summary**

BA (Hons) Art Practice provides an outstanding programme of delivery that combines theoretical perspectives with the development of high-level practical skills. Innovative idea-generation and problem-solving are at the heart of the course to enable students to develop successful visual solutions with originality and flair. The course framework has been designed to enable the development of critical contextual skills, emphasising and encouraging creative growth through research. Central to our ethos is the notion that through exposure to art theory, analysis of contextual material and critical reflection, visual awareness is developed and effective strategies to convey meaning are formed.

The course is interdisciplinary and cross-specialist, facilitating students wishing to explore a range of specialisms to develop an individual creative process through enquiry and experimentation. As such, BA (Hons) Art Practice is designed to enable creative individuals

### Course Aims

1. To develop student's understanding of art practice and their capacity to be creative.
2. To gain a solid understanding of a broad range of art materials, techniques and processes to facilitate the application of divergent ideas in original, innovative ways.
3. To enable students to develop critical contextual skills.
4. To develop students' appreciation of the necessity to create art outcomes that demonstrate quality and detail.
5. To help students acquire skills in intellectual inquiry, investigation and critical reflection.
6. To enable students to develop a capacity to work independently with resilience and self determination.
7. To develop skills in team-work and collaboration for the purpose of creating, marketing and selling works of art.
8. To enable students to develop a unique creative practice with commercial potential.
9. To enlighten students to the importance of theory and its relationship with practical processes.
10. To provide students with the practical and technical information necessary to pursue a career in professional art practice.
11. To help students gain a concrete all-round knowledge of the subject of art practice to enhance and inform their chosen art discipline.
12. To enable students to select an appropriate art discipline to pursue professionally.

### Course Learning Outcomes

The following statements define what students graduating from the BA (Hons) Art Practice course will have been judged to have demonstrated in order to achieve the award. 4. Produce an effective showcase of skills, mind-set and creative ambition through the formulation of a professional portfolio of creative work.
5. Present creative outcomes pertinently to professional, industry standards.

6. Possess a sophisticated understanding of the broad, critical dimensions of professional art practice.
7. Critically apply abstract concepts and theoretical perspectives to solve challenging creative problems.
8. Utilise complex idea-generation methods to generate innovative concepts.

**Awards**

On successful completion of the course, students will be awarded a BA (Hons) Art Practice. Students who leave the course early may be eligible for a DipHE Art Practice on successful completion of 240 credits including all mandatory modules at levels 4 and 5, or a CertHE Art Practice on successful completion of 120 credits including all mandatory modules at level 4.

**Course Delivery**

The course is delivered at University of Suffolk at West Suffolk College. Students studying full-time on BA (Hons) Art Practice are likely to have approximately 272 contact hours for level 4, 258 contact hours for level 5 and 192 contact hours for level 6. The contact hours will be a mix of lectures, seminars, practical workshops and one-to-one tutorials. Students will normally be expected to undertake 38 hours of independent study in an average week, but should be prepared for this to vary based on assignment deadlines and class exercises.

**Course Assessment**

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall is 100% coursework based (including essays, reports, presentations, group work, reflective learning journals and research projects).

**Course Team**

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute.

### Course Costs

Students undertaking BA (Hons) Art Practice will be charged tuition fees as detailed below.

Payment of tuition fees is due at the time of enrolment and is managed in accordance with the Tuition Fee Policy.

Students will be required to pay additional costs for trips, amounting to a maximum of £50 per semester, payable at a later date. An optional international residential trip may be offered – details of which will be provided when the course commences.

Students are likely to incur other costs for equipment and materials amounting to approximately £150 per year.
