Course Summary

For those students who successfully complete the FdA Children’s Care, Learning and Development, and who are interested in progressing their studies within the field can progress on to the BA (Hons) Children’s Care, Learning and Development. Students study early intervention, child health and professional practice alongside their dissertation study. Topics

offered for dissertation last year included identification of gifted and talented children, the value of home visiting in transitions and whether the school starting age is too young. Future employment opportunities exist in schools, children's centres, playgroups, nurseries, social care and voluntary organisations. As part of the course students will need to have face-to-face contact with children for at least 20 hours per week. Students will require the support of their employer to successfully complete the qualification. Students will need a mentor in the workplace to support them with their studies.

Course Aims

- To ensure in-depth critical understanding of children's development in the context of western society.
- To develop and enhance the thorough application of theory to practice through self-negotiated assessments and reflection.
- To encourage the development of transferable and employability skills which can be applied to current and future practice.
- To ensure critical understanding of legislative frameworks and their application to practice.

Course Learning Outcomes

The following statements define what students graduating from the BA (Hons) Children's Care, Learning and Development [progression route] course will have been judged to have demonstrated in order to achieve the award. These statements, known as learning outcomes, have been formally approved as aligned with the generic qualification descriptor for level 6 awards as set out by the UK Quality Assurance Agency (QAA)⁶.

1. Detailed and well-developed knowledge and critical understanding of theories of children's development and education, and how they can be applied to the children's workforce.
2. Application of an effective working knowledge of current evidence bases of practice and able to critically evaluate these in relation the learning process that children experience.
3. An ability to make and justify sound recommendations to develop practice based upon detailed analysis of evidence based practice.
4. An ability to critically interrogate the assumptions behind evidence bases, and draw effective and valid conclusions from this.
5. An ability to identify contradictions evident in some discourses of education and to be able to evaluate the implications of this for practice.

Awards

On successful completion of the course, students will be awarded a BA (Hons) Children's Care, Learning and Development.

Course Delivery

The course is delivered at the University of Suffolk at East Coast College (Lowestoft). Students studying full-time on BA (Hons) Children's Care, Learning and Development [progression route] will have for each 20-credit module 60 hours of tutor led teaching over the semester as a whole. The teaching led activities will be a mix of lectures, seminars, academic tutorials, and Virtual Learning Environment (VLE) activities. Students will normally be expected to undertake

approximately 140 hours of independent study per 20 credit module, but should be prepared for this to vary based on assignment deadlines and class exercises. In the case of the dissertation there is a requirement for 385 hours of independent study with 15 hours per student of direct supervision.

Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be 100% coursework (including essays, reports, presentations and a dissertation).

Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute.

Course Costs

Students undertaking BA (Hons) Children's Care, Learning and Development [progression route] will be charged tuition fees as detailed below.
