- To give students the opportunity to apply knowledge in practical situations
- To enable students to develop essential skills through reflective practice

### Awards

On successful completion of the course, students will be awarded a BA (Hons) Event and Tourism Management. Students who leave the course early may be eligible for a DipHE Event and Tourism Management on successful completion of 240 credits including all mandatory modules at levels 4 and 5, or a CertHE Event, Tourism and Marketing on successful completion of 120 credits, including all mandatory modules at level 4.

The course is delivered at Ipswich. Students studying full-time on BA (Hons) Event and Tourism Management are likely to have approximately 232 tutor structured learning hours for level 4, 210 tutor structured learning hours for level 5 and 180 tutor structured learning hours for level 6. Tutor structured learning will be a mix of lecture, seminar and practical activities. Students will also be required to participate in 100 hours of work-based learning opportunity in level 5 and again in level 6. Full-time students will normally be expected to undertake 25-30 hours of independent study in an average week; but should be prepared for this to vary based on assignment deadlines and class exercises.

### Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. All assessment on the course will be coursework including essays, reports, presentations, group work, reflective learning journals and research projects.

### Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute.

### Course Costs

Students undertaking BA (Hons) Event and Tourism Management will be charged tuition fees as detailed below.
