This definitive record sets out the essential features and characteristics of the LLB (Hons) Law with Politics (with Professional Placement and Study Abroad) course. The information provided is accurate for students entering level 4 in the 2022-23 academic year<sup>5</sup>.

### Course Summary

Law is taught from a range of perspectives, based on the finest traditions of legal education and recent innovations for the 21<sup>st</sup> century. Our approach is to examine law well beyond basic legal rules and legal institutions, taking account of wider contexts and discourses that allow deeper understanding of law in society. With this approach, the University of Suffolk provides students with firm grounding in the subject of law and the contexts in which law functions. Equally important is the breadth and depth of education that this subject facilitates. Students will be equipped to take on challenging questions about law and related issues, and to apply their knowledge and skills in a variety of contexts. This ethos runs right through all subjects in the law curriculum and enhanced even more with combinations in other social sciences.

This course places emphasis on the use of law to solve problems. With this in mind, teaching and learning on this course is designed to encourage the development of strong legal and problem-solving skills. In addition to engaging in legal reasoning, students also learn how to analyse the impact of law in society. Though law is often studied as a distinct subject, its methods and analytical approaches draw on fields within the humanities and the social sciences. Students will have the opportunity to develop skills in the use of a wide range of legal research methods and approaches, with increasing emphasis on independent work as you progress through your course. The course also emphasises the importance of developing a range of legal and academic skills to enable students to learn, research and analyse the law as independent learners to prepare them for further study or a variety of legal careers. This course also recognises the importance of practical legal skills for employability, and endeavours to infuse skills-based learning on all modules.

Politics at Suffolk seeks to enable students to take an informed, independent perspective on power, ideas and values, taking into account political theory, British politics and international comparative politics. Throughout the course, we will maintain a critical focus on how political ideas and policies translate into 'real, felt' political action and outcomes 'on the ground'. This includes, for example, relating theory to contemporary social justice and social policy issues. It also includes students' active engagement in the subject and the course is built around a backbone of students' involvement in project work, applied social science research and

opportunities for political engagement and professional development. By the end of the course, as well as having gained a good, broad knowledge of political science, students will be ready to enter employment or further study with skills in political analysis, critical awareness of the organisational context of change and influence, and interpersonal skills in advocacy and persuasion.

### **Course Aims**

1. To develop extensive knowledge and understanding of a broad range of legal areas including the core foundational subjects as well as specialist areas.
2. To expose students to core legal concepts, principles and values to allow them to understand the context in which law operates and to facilitate the careful analysis of individual legal rules.
3. To allow for the critical evaluation and engagement of a range of primary and secondary sources to encourage evidence-based legal analysis.
4. To introduce a range of legal research methods to allow students to conduct objective and competent legal research to examine and propose solutions for legal problems.
5. To facilitate opportunities for students to develop legal skills such as oral and written advocacy, legal writing, critical analysis of conflicting sources and arguments, and ability to conduct accurate and reliable legal research.
6. To develop students into becoming independent learners and researchers.
7. To develop subject specific, cognitive and employability skills for personal development, postgraduate study and a range of graduate careers including entering legal practice.
8. To promote increasing participation in education for the local community by supporting a range of learners, including non-traditional entrants, at degree level.
9. To develop students' knowledge, critical understanding and skills in Politics

### **Course Learning Outcomes**

The following statements define what students graduating from the LLB (Hons) Law with Politics (with Professional Placement and Study Abroad) course will have been judged to have demonstrated in order to achieve the award. 4. Demonstrate sophisticated knowledge and application of legal research theories, methodologies, and methods as part of an independent project.
5. Demonstrate knowledge and critical engagement with a range of approaches, theories, concepts, research findings and applications in the study of politics relating to the operation of power.
6. Critically examine the social, economic, historical, and cultural contexts of political behaviour and the development, structure and operation of different political systems.

7. Critically evaluate a range of primary and secondary sources identifying limitations and weaknesses of particular sources.
8. Discuss the law from different perspectives such as moral, social economic and political.

Optional modules available in any year will be communicated to you prior to your enrolment to facilitate module choice. Some optional modules may not run in every year of study, and the availability of optional modules depends on the level of student demand, the availability of specialist staff and timetabling constraints. In addition, we regularly review our curriculum to ensure it is up-to-date, relevant, draws on the latest research and addresses contemporary issues. As a result, the modules we offer may change over the course of your degree.

### Awards

On successful completion of the course, students will be awarded a LLB (Hons) Law with Politics (with Professional Placement and Study Abroad).

Students who leave the course early may be eligible for a LLB Law with Politics on successful completion of 300 credits including all mandatory modules at levels 4, 5 and 6 (excluding the Independent Project), a DipHE Law with Politics on successful completion of 240 credits including all mandatory modules at levels 4 and 5, or a CertHE Law with Politics on successful completion of 120 credits including all mandatory modules at level 4.

### Course Delivery

The course is delivered at Ipswich main campus. Students studying full-time on LLB (Hons) Law with Politics (with Professional Placement and Study Abroad) are likely to have approximately 12 tutor led structured learning hours per week for level 4, 9 tutor led structured learning hours per week for level 5 and 9 tutor-led structured learning hours per week for level

6. The tutor led structured learning hours will be a mix of online activities, recorded and live online sessions and face-to-face learning sessions. Students will normally be expected to undertake 28 hours of independent study in an average week, but should be prepared for this to vary based on assignment deadlines and class exercises.

### Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be approximately 85-90% coursework (including essays, reports, presentations, group work, reflective learning journals and research projects) and 10-15% examinations.

### Special Features

The course also complies with the QAA Subject Benchmark Statement for Law (November 2019) and incorporate all of the foundations of legal knowledge subjects as required by the Bar Qualification Manual.

### Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute to the course.

### Course Costs

Students undertaking LLB (Hons) Law with Politics (with Professional Placement and Study Abroad) will be charged tuition fees as detailed below.
