This definitive record sets out the essential features and characteristics of the BSc (Hons) Physiotherapy course. The information provided is accurate for students entering level 4 in the 2022/23 academic year<sup>5</sup>.

### Course Summary

Physiotherapy is a healthcare profession which sees human movement as central to the health and wellbeing of individuals of all ages. Through person centred care a physiotherapist helps to identify and maximise movement potential and quality of life through health promotion, preventive healthcare, and specialist assessment, treatment, and rehabilitation. This contemporary course is designed to support and develop modern, entrepreneurial physiotherapists who feel confident to commence their career in a variety of settings.

During this degree students will learn the essential knowledge, skills, behaviours, and values required to reach the standard for qualification as a physiotherapist. Seven placement experiences are embedded during the course to ensure students achieve the minimum 1000 hours of practice. Following the successful completion of this course students would be eligible to apply for registration as a Physiotherapist with the Health and Care Professions Council and you would also be eligible to apply for membership as a Chartered Physiotherapist with the Chartered Society of Physiotherapy.

### Course Aims

1. To provide students with the knowledge, skills, behaviour, values and professionalism that will enable them to work, effectively, flexibly and responsively as an autonomous and reflective physiotherapy practitioner in a variety of service and practice settings.
2. To develop graduates who provide high quality person-centred physiotherapy practice which is delivered in partnership with patients and carers in existing and emerging health and well-being environments.
3. To promote an inquisitive evidence-based and research-informed approach to the application of high-quality contemporary physiotherapy practice across a diverse range of settings and populations through a process of critical evaluation, clinical reasoning and reflection.
4. To provide a supportive active learning environment in which students are encouraged to develop skills for life-long learning, personal and professional goals, emotional intelligence, digital literacy, cultural competence, and problem-solving to enable them to develop as an autonomous practitioner.

5. To equip students with the ability to drive the profession and healthcare forward by developing the skills of accountability, resilience, leadership, enterprise, entrepreneurship and innovation.

### Awards

On successful completion of the course, students will be awarded a BSc (Hons) Physiotherapy. Students who leave the course early may be eligible for a DipHE Rehabilitation Science on successful completion of 240 credits including all mandatory modules at levels 4 and 5, or a CertHE Rehabilitation Science on successful completion of 120 credits including all mandatory modules at level 4.

### Course Delivery

The course is delivered at Ipswich. Students studying full-time on BSc (Hons) Physiotherapy are likely to have approximately 360 contact hours for level 4, 250 contact hours for level 5 and 117 contact hours for level 6. The contact hours will be a mix of lecture, seminar, practical activity and students will also be required to participate in a minimum of 1000 hours of work placement across the three years of the programme. Placements will be arranged by the University. Students will normally be expected to undertake 30 hours of independent study in an average week but should be prepared for this to vary based on assignment deadlines and class exercises.

### Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be approximately 27% coursework (including essays, poster presentations, group work, reflective accounts, digital video production, research projects), 41% examinations, including Objective Structured Clinical Examination and 32% practical assessments.

### Special Features

On successful completion of the BSc (Hons) Physiotherapy students, subject to approval by the HCPC, are eligible for registration with the HCPC and eligible for membership with the Chartered Society of Physiotherapy.

### Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute and are registered with the appropriate professional body.
