This definitive record sets out the essential features and characteristics of the BA (Hons) Politics and History course. The information provided is accurate for students entering level 4 in the 2023-24 academic year⁵.

Course Summary

Politics is about power, ideas and values. The study of politics and history are deeply intertwined but sometimes use different perspectives, methods and questions. The Politics and History course at Suffolk will give students the knowledge and space to engage deeply with political and historical trends and to assess the world around them. In terms of politics, in addition to acquiring an understanding of British and international political structures and social trends, our course offers a distinct focus on political and social action across party politics and campaign and community politics. In terms of history, the course is characterised by a chronological focus on the period from 1500 to the modern day. Within this chronological range the course is concerned to explore experiences and themes in Global and British History (encompassing national, regional, and local experiences and perspectives) as well as the interrelation between historical experiences on these levels. The course is also active in its delivery with an emphasis on group work, project work, employability and engagement with political organisations (broadly defined).

Course Aims

- To investigate the nature, forms, causes and consequences of politics.
- To study power and engage deeply with political and social theory and philosophy.
- To analyse local, national, regional and supranational power structures and their consequences for people.
- To provide an intellectually stimulating and satisfying experience of academic history with guidance and encouragement to develop both theoretical and practical capabilities in its study.
- To allow for an engagement with (broadly defined) political organisations through the use of group work and project work.
- To develop an appreciation of how people have existed, acted, and thought in the always different context of the past.
- To develop subject specific, cognitive and employability skills for personal development, postgraduate study and a range of graduate careers.
- To investigate the changing nature of social life with its consequences for patterns of diversity, inequality, and injustice.

Course Learning Outcomes

Optional modules available in any year will be communicated to you prior to your enrolment to facilitate module choice. Some optional modules may not run in every year of study, and the availability of optional modules depends on the level of student demand, the availability of specialist staff and timetabling constraints. In addition, we regularly review our curriculum to ensure it is up-to-date, relevant, draws on the latest research and addresses contemporary issues. As a result, the modules we offer may change over the course of your degree.

Awards

On successful completion of the course, students will be awarded a BA (Hons) Politics and History (with Professional Placement, BA (Hons) Politics and History (with Professional Placement and Study Abroad) or BA (Hons) Politics and History (with Study Abroad) depending on the sandwich route taken. Students who leave the course early may be eligible for a BA Politics and History on successful completion of 300 credits at Level 4 or above (including at least 180 credits at Level 5 or above and at least 60 credits at Level 6), a DipHE Politics and History on successful completion of 240 credits including all mandatory modules at levels 4 and 5, or a CertHE Politics and History on successful completion of 120 credits including all mandatory modules at level 4.

Course Delivery

The course is delivered at University of Suffolk. Students studying full-time on BA (Hons) Politics and History are likely to have approximately 12 hours per week (288 hours per year) structured learning for level 4, 9 hours per week (216 hours per year) structured learning for level 5 and 8 hours per week (192 hours per year) structured learning for level 6. Tutor structured learning will be a mix of lectures, seminars, workshops, tutorials and guided learning activities which take place on campus and through our online learning environment. There is an optional work placement and work shadowing opportunity equivalent to 10 days in the final year of study. Students will normally be expected to undertake 28 hours of independent study in an average week at level 4, (672 hours per year), 31 hours of independent study at level 5, (744 hours per year) and 32 hours of independent study at level 6, (768 hours per year), but should be prepared for this to vary based on assignment deadlines and class exercises.

Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be mostly coursework (including essays, reports, presentations, group work, reflective learning journals and research projects).

Course Team

The academic staff delivering this course are drawn from specialist politics, history and social science teaching teams.

Course Costs

Students undertaking BA (Hons) Politics and History with sandwich route will be charged tuition fees as detailed below.
