This definitive record sets out the essential features and characteristics of the FdA Social Welfare, Advice & Guidance Practice course. The information provided is accurate for students entering level 4 in the 2023-24 academic year.⁵

Course Summary

This course has been developed to meet the education and training requirements of a range of individuals employed within the statutory, voluntary and not-for-profit welfare, advice, guidance and social care sectors. It offers students the opportunity to enhance their work-based skills and achieve a recognised academic qualification. The course has been developed in liaison with employers and employees in the social care sector, including agencies who deliver information, advice and guidance support and has been tailored to meet the specific training requirements of the sector. The students study a range of modules, all of which they are able to shape to their own practice and interests. These include: Personal & Professional

Course Aims

- To provide students with the knowledge, understanding and associated skills that will enable them to work effectively, flexibly and responsively with Children, Families and Adults in welfare, advice, guidance and social care sectors
- To enable students to recognise the scope, depth and breadth of their knowledge and skills to work inclusively within an inter-professional team
- To provide students with an appropriate understanding of the regulatory and legislative framework for welfare, guidance or social care pertinent to their role
- To provide opportunities for students to develop key skills to prepare for further study and / or employment and life-long learning
- To encourage students to become active learners, thus learning through practice, rather than learning to practice
- To provide the students with the opportunity to explore methods of research relevant and appropriate to work settings
- To enhance the students' communication and interpersonal skills
- To develop students' enthusiasm for higher education
- To provide opportunities for reflection and development of personal and professional skills whilst working within the welfare, advice, guidance and social care sectors
- To provide students with a recognised higher education qualification which provides the opportunity to access an honours degree and / or a professional qualification

Course Learning Outcomes

The following statements define what students graduating from the FdA Social Welfare, Advice & Guidance Practice course will have been judged to have demonstrated in order to achieve the award. Awards

On successful completion of the course, students will be awarded a FdA Social Welfare, Advice & Guidance Practice. Students who leave the course early may be eligible for a CertHE Social Welfare, Advice & Guidance Practice on successful completion of 120 credits including all mandatory modules at level 4.

Course Delivery

The course is delivered at the University of Suffolk at East Coast College (Great Yarmouth). Students studying full-time on FdA Social Welfare, Advice & Guidance Practice are likely to have approximately 9-12 contact hours per week. The contact hours will be a mix of lectures, presentations and tutorials as well as via the online learning environment (Brightspace). Students are expected to already be working in the sector. Students should expect to do at least 10 hours per week of work either in employment or a voluntary role. Support can be provided in finding work placements when necessary. Students will normally be expected to undertake approximately 20 hours of independent study per week.

Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be 100% coursework (including essays, presentations and work-based project tasks). Filmed evidence will be used for formative assessments and reflections, in some of the modules.

Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute.
